### 2. APPROVE MINUTES FROM MEETING OF APRIL 29

The Chair communicated one change to the minutes to mark Marie Bowman as present (non-voting due to her participation via Zoom from a private location).

# 3. APPROVE NEW MEMBERS

\* In agenda item #4 members agreed to adopt the trade name East Bay Wildfire Coalition of Governments (EBWC) instead of the non-descriptive legal moniker: Wildfire Prevention Coordinating Group (WPCG).

The Kensington Fire Protection District did not approve the MOU at its most recent meeting. Therefore, the City of Pinole represented by Mayor Maureen Toms is the only new jurisdiction to join at this meeting.

Once the organization has a Fiscal Agent, only the Fiscal Agent's signature is needed to formally accept new members. In the absence of a Fiscal Agent, the Board is required to take a motion.

**PUBLIC COMMENT: None** 

**ACTION**: Motion by Wengraf, seconded by Bowman: *Recognizing the* ratification of the Memorandum of Understanding for Coordination of Wildfire Prevention Activities to Protect the East Bay Hills in Alameda and Contra Costa Counties by its governing body, and in the absence of a Fiscal Agent, the Participating Agencies hereby welcome the City of Pinole, represented by Mayor Maureen Toms, to be an official Participating Agency.

**VOTE**: 7-0-0: Passed unanimously

# 4. NAME OF ORGANIZATION

Chair Wengraf proposed a more descriptive name for the group: the East Bay Wildfire Coalition of Governments, using the acronym EBWC. According to legal advice, the organization use any 'trade name' it wishes as long as the moniker is adopted by the members.

**ACTION**: Motion by Toms, seconded by Ramachandran to approve the new trade name for the organization: the East Bay Wildfire Coalition of Governments (EBWC).

# 6. FINANCIAL REPORT

Lisa Jacobs reported that approximately \$10,000 remains at the Oakland Firesafe Council's bank account from community-raised funding to support the creation of the EBWC. This amount does not include the \$16,000 still to be received from the City of Oakland and the Bay Area Council Economics Institute. In addition, OFSC has identified an anonymous donor to provide additional funds. Ms. Jacobs encouraged the group to consider financing and strategy development as a joint goal given that the organization cannot consider programs until identifies ongoing funding. Contra Costa County has expressed openness to consider having the CCCFD act as fiscal agent for the EBWC; a meeting with relevant officials is scheduled later in July.

# **Strategic Framework One-Pager**

During the recess, the ad hoc committee: Chair Susan Wengraf, Vice Chair Janani Ram achandran, Supervisor John Gioia and Councilmember Gayle McLaughlin, worked to develop a proposed strategic framework that identifies the organization's purpose/mission, areas of interest, and immediate priorities.

The attached Strategic Framework "One Pager" is intended to help define and communicate strategic priorities of the newly formed organization. It is not meant to be an over-arching strategy document; long-term goals and specific activities are still to be defined.

The components of the strategic framework that the EBWC is being asked to adopt are:

- 1. Mission Statement: The proposed mission statement (text in italics) briefly describes who we are and what we (intend to) do: The East Bay Wildfire Coalition of Governments (EBWC) is a regional consortium of elected officials representing cities, counties and fire districts committed to safeguarding our communities and natural landscapes in the East Bay Hills. We champion proactive, cooperative approaches to mitigating, through education and collaboration, the increasing threat of wildfires due to the climate crisis.
  - a. **FOR DECISION**: Discuss and approve the mission statement
- 2. Strategic Focus: The ad hoc committee identified two program areas to focus our efforts and gain some "quick wins":
  - 1) home hardening to include defensible space and "zone zero" with three specific objectives: education, legislation and funding;
  - 2) vegetation management develop a science-based, ecologically sound, regionwide vegetation management plan.
    - a. FOR DECISION: Discuss and agree that the current focus areas of the EBWC are home hardening and vegetation management, pursuing the activities described in the onepager
- 3. Areas of Interest: Five program areas were defined in the MOU as our "Shared Intent". The one-pager merely translates the MOU contents into concise language.
  - a. **FOR DECISION**: Discuss and agree that the one-pager reflects EBWC members' shared intent.
- 4. Members: Lists current members jurisdictions and their representatives; Strategic Partners; role of fire chiefs.
  - a. **FOR DECISION**: Discuss and agree that that list of members currently reflects EBWC and its relation to regional partners and fire departments.

Once the concept and contents are approved by the EBWC, a designer can be retained to create a more professional-looking document.

- **Funding:** Create regional assistance program for homeowners to implement "zone zero"

# **Focus: Vegetation Management**

- Funding: Raise funds for situational analyses, plans and environmental impact report for a regionwide vegetation management plan
- **Project management**: Apply for grants, distribute funding and support activities

# **Options for Member Fee Structure**

The effort to create the EBWC has been largely driven by volunteers, with professional consulting help that has been financed by funds raised by the coalition. Now that the EBWC is formed the EBWC needs to consider how its work will be supported in the future. Funds are running low.

To do the work envisioned, some professional help will be needed for the organizing, program development, fundraising and management work required to meet the goals of the strategic framework. Therefore the ad hoc committee has considered options for a member fee structure. As noted in the MOU, the fee structure must be approved by 100% of members.

A budget of \$100,000 for year 2025 is proposed. Given budget timelines and the urgent need for funding, we have also developed a reduced budget option.

# Option 1 -Full \$100k

The two counties carry the majority (60%) of the total fees annually; their share is split equally. The remaining 40% is split between the local member jurisdictions\* based on population size. There is a proposed minimum fee of 3% (\$3,000) for all members.

# **Option 1 – Reduced -\$60k**

In the interest of raising funds quickly, this option gives jurisdictions smaller amounts to bring back to their respective decision-making bodies. But it only raises \$60,000.

# Option 2-Full \$100k

The two counties carry one half (50%) of the total fees annually; their share is split equally. The remaining 50% is split based on the amounts that several member cities invested in the past – amounts noted in the spreadsheet. This option also includes a minimum fee of 3% (\$3,000) for all members.

### Option 2 – Reduced \$60k

Uses the Option 2 scenario with a smaller target budget.

**FOR DECISION**: Discuss and vote on the preferred option to bring back to local jurisdictions for consideration.

<sup>\*</sup> The Rodeo Hercules Fire District is not envisioned to pay any fees. It will soon be subsumed into Contra Costa Fire Protection District.
