- developed the Oakland Community Preparedness & Response (OCP&R)
  educational program that includes a 1-hour online workshop presentation and a website with preparedness checklists, 22 detailed Guides (translated into Spanish),
  4 instructional videos and additional materials to help Oakland residents prepare for and respond to a major disaster such as a wildfire. <a href="https://www.oaklandcpandr.org/">https://www.oaklandcpandr.org/</a>
- presented the OCP&R program to over 1,300 residents and local agencies, including at 2 Oakland Town Halls webinars.
- delivered the 1-hour OCP&R workshop (in-person and then via Zoom post-COVID-19) to over 400 residents.
- created a social media presence with Twitter, Facebook and Instagram pages to promote the OCP&R program on a regular basis.
- created 44 weekly eNewsletter publications and sent each to a distribution list of currently over 820 Oakland residents.
- created the GENOAK emergency GMRS 2-way radio repeater network for Oakland and surrounding cities to enable neighborhood-to-neighborhood communications

during and after a disaster (primarily funded by another grant but part of our OCP&R program to help facilitate emergency coordination and response), as well as a website with information on the GENOAK program – currently over 100 leads in neighborhood groups in and around Oakland participate in GENOAK. https://www.genoak.org/


- developed a workshop on emergency preparedness education for older adults, and presented to senior communities and agencies in and around Oakland.
- received press on the OCP&R program including the Easy Bay Times, Oaklandside, Rockridge News, Channel 5 News and the Claremont Canyon Conservancy news.
- received a matching grant from the City of Oakland for on-going activities and joint projects with the Emergency Management Services Division of the Oakland Fire Dept, the grant is currently in final legal review by the City.

Challenges faced during the grant. (i.e. delays due to the weather, contract bids coming in higher or lower than planned, change of project manager, location change, etc.)

- the COVID-19 Shelter-in-Place and social distancing mandates put an immediate halt to our in-person, instructor-led OCP&R workshops in Q1, 2020, resulting in a pivot to develop and deliver the workshop online via Zoom.
- COVID-19 and social injustice issues were higher priorities and concerns during 2020 (understandably) for many people, compared with emergency preparedness, resulting in more effort to sign-up participants in the OCP&R workshop.

- met our Project Plan timeline and deliverables with the development of the OCP&R program and the release of the workshop, website, 22 Guides, additional materials and weekly eNewsletters to Oakland residents.

How challenges impacted the overall grant accomplishments and how you remedied the situation. (i.e. one month delay in completing CEQA but we were able to redirect additional camp crews to work on the project so we were able to complete within the grant period, will be treating fewer acres, etc.)

- while difficult to quantify the impact of COVID-19 on the adoption of the OCP&R program, there was a 3 month delay from the last in-person, instructor-led OCP&R workshop in March, 2020, to the first online Zoom workshop in June, 2020. Online Zoom workshops then increased in frequency during the 2<sup>nd</sup> half of 2020 to present.

**Overall accomplishment and impacts** (i.e. treated 110 acres instead of the 100 acres planned within funding allotted, exceeding accomplishments by 10%, were able to train 200 employees on <insert date>, provide education to X attendees at X community education events during the Fresno County Fair from July 15-18<sup>th</sup>, etc.).
