#### **RE-OPENING OAKLAND'S FIRE STATIONS**

### Oakland City Councilmembers Share the Good News



Councilmember Janani Ramachandran (District 4) talks with Oakland Fire Chief Damon Covington about a recently passed City Council resolution that will allow three temporarily closed fire stations to reopen, as well as newly identified funding that will prevent the closure of four additional stations.

District 1 City Councilmember Zac Unger describes the decision as "a big win for public safety as the council unanimously passed the legislation that Councilmembers Janani Ramachandran (D4) and Rebecca Kaplan (Interim D2), and I introduced to protect fire services. We will reopen the three shuttered stations before the end of June and we will NOT proceed with the planned closure of four additional stations. All of our Council colleagues have been working tirelessly to find funding to protect our fire stations. I want to thank everyone on the Council and in the offices of the City Administrator and Mayor for their hard work on this legislation to restore our fire services. Also thank you to everyone who has emailed, called, and messaged the Council these last few months, urging us to protect fire services."



OFSC President, Elizabeth Stage, spoke on our behalf to thank Council Members Unger, Kaplan, and Ramachandran for their work and to support keeping as many fire stations open as soon as possible. She reports, "It was great to testify with so many community members and at least a dozen fire fighters."



# CONFUSION OVER LRA FIRE HAZARD SEVERITY ZONE MAPS

On February 24th, 2025, CAL FIRE released its updated DRAFT Local Responsibility Area (LRA) Fire Hazard Severity Zone maps, which include the Oakland/Berkeley hills.

While these were expected updates following previously updated State Responsibility Area (SRA) maps, what was unexpected and surprising was that the High and Very High Fire Hazard Severity Zone (FHSZ) areas, especially



in the Oakland hills, were significantly decreased in size. Most folks involved in wildfire safety, including OFSC, had expected an increase in size...!
