## A CALL TO ACTION

From Oakland Firesafe Council President, Elizabeth Stage

(Note: in the time since Elizabeth sent the following message for publication, mandatory evacuations have been ordered for wildfire near Lake Sonoma.)

In the last week, we've seen wildfires in and around Livermore and Tracy; The National Weather Service has issued a Red Flag Warning this weekend from Redding to Fairfield, has reminded Bay Area residents that gusting wind should prompt caution with outdoor activities that prompt sparks.

Wondering how to channel your anxiety into something more productive? OFSC's work over the last decade has helped to create many mechanisms that can and will make us less likely to suffer catastrophic loss from fires. Many of our efforts are coming to fruition in the next few weeks and months and we're hoping that you'll be inspired to take some steps with us, so we'll be successful together.

The Wildfire Prevention Zone (WPZ) and the Wildfire Prevention Coordinating Group (WPCG) are evidence. For a personal reflection, read David Kessler's message below. From a policy perspective, the WPZ and the reasons we should support it tie together several initiatives that OSFC has spearheaded or collaborated on with other community organizations and partners.

The WPZ is a ballot measure that's scheduled for a final vote by the Oakland City Council on **June 26th**; **the meeting starts at 1:30pm**

1991 Wildfire Safety Dreams Finally Becoming Reality in 2024?

"After the 1991 fire, returning residents had two dreams about making their future safe. The first was a regional approach to vegetation management; the fire did not see the border between Oakland and Berkeley. This year, with the creation of the Wildfire Prevention Coordinating Group, Oakland is now part of a network of East Bay governments that can plan and execute in concert. We have regional planning at last, 30 plus years later.

The second dream was a source of funding for essential annual vegetation management would be independent of the General Fund and the fluctuations of the City Budget. The City has tried to set up such a source before, with the creation of the Wildfire Prevention Assessment District. Both the funding and the operation of the WPAD were imperfect, leading to its eventual failure. With the proposed Wildfire Prevention Zone, a simple mechanism for financing and a detailed Vegetation Management Plan to blueprint its work, we hope that we will have the work for a safer environment paid for every year.
