BY THE NUMBERS



In our previous newsletter we shared that, through a grant from PG&E, OFSC successfully facilitated and completed critical vegetation management and fire mitigation projects on twenty-three residential properties and three key City of Oakland properties. Here's a few to review (and check out those numbers!):

Spees Canyon – 60 cubic yards of fuel removed



Defensible space creation at Spees Canyon (Cityowned property) by extensively clearing vegetation that previously posed a direct wildfire threat to surrounding residences: Chipping logs and branches on ground, weed whacking of overgrown

Corner of Oakwood & Wild Currant – 56 cubic yards removed



Evacuation Route
Clearance: Ensuring clear,
safe egress for residents by
removing tree tunnels and
overgrown hazards: trees
along Oakwood and Glen
Oaks Drive down to Wild
Current were pruned up and
trimmed back so that they
didn't hang over the street.

Upper Sausal Creek (corner Ascot /Mastlands) – 100 cubic yards removed



Structural protection at Upper Sausal Creek (Cityowned property) with aggressive vegetation removal to protect adjacent homes from wildfire: Removal of two big bay branches in creek, prune all tree branches up 10', removed dead vegetation on

vegetation 20' south and 20' North to large pine at top, prune all tree branches up 15' off the ground. Clearing of overgrown invasive vegetation at corner of Wild Current/Oakwood that was growing into the evacuation route.
