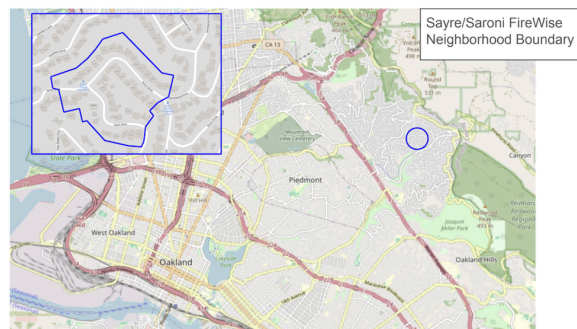

The Sayre/Saroni Firewise Neighborhood consists of 47 homes near the intersection of these two streets. Jim Floyd, resident Firewise lead, shared:

## MAYOR PROUD OF OFD'S HISTORIC YEAR



At the end of December 2025, Mayor Barbara Lee shared a short reel on social media about Oakland Fire Department:

"Oakland Fire had a historic year. For the first time in over 20 years, all 25 fire stations are open and fully staffed - giving our firefighters the resources they need to effectively respond to over 70,000 911 calls per year.

**On wildfire prevention**, we deployed 5,500 goats to clear 1,300+ acres of hazardous vegetation and conducted 25,000 property inspections in hillside communities..."

## ZONE ZERO... WHAT NOW?



**Zone 0 regulations were supposed to be finished by the end of 2025. They weren't.**

After five years of hearings, testimony, and near-final drafts grounded in wildfire science, the Zone 0 rulemaking process stalled at the very moment it was expected to conclude.

Strong support from firefighters, fire scientists, Firesafe, and Firewise communities was met with escalating pushback, largely from Southern California interests opposed to removing vegetation near homes. As the statutory deadline passed without adoption, it became clear that the remaining obstacle was no longer technical.

# RESILIENT NEIGHBORHOODS NETWORK

The Resilient Neighborhoods Network is a growing collective of interdependent neighborhood associations in the Bay Area that are dedicated to building collective resilience through community connection, preparedness, and mutual support.



According to organizer Shirah Wagner, "The Resilient Neighborhoods Network had a very successful second meeting + potluck on December 15th at Oakland Firestation 1.

33 people showed up from over 20 neighborhoods. Partners like EMSD, Red Cross, Alco VOAD, Tzu Chi, Oakland Firesafe Council, and CORE Response shared introductions to their work.



Guest speaker Kat Vellos, professional community builder and author of *We Should Get Together*, spoke on the importance of hyper-local community and connections.

We got into groups and discussed specific needs we had around our resilience efforts (**the majority wanted more practical, hands-on training**) and got to know each other better."
