After conferring with numerous local elected officials and fire chiefs, it was agreed that, rather than immediately forming a Joint Powers Agency, an intermediate step would be to expand and enhance the existing Hills Emergency Forum. The HEF currently is a less formal organization of fire chiefs from agencies in both Alameda and Contra Costa countries. The leadership of the existing HEF will meet to decide on May 10.

c. City of Oakland Wildfire Prevention Interagency Team – Joe Devries

## FOR INFORMATION:

Logs are being placed according to plans and in some cases ahead of schedule.

Grizzly Peak – reconvened interagency alliance and there was universal agreement that 2021 July 4 plan will be in force 2022.

Goats starting in next 2 weeks. Caltrans goats also starting in next two weeks.

Starting talking about reestablishing an MOU between OFD and OPW. Historically OFD has had veg management contracts because of WPAD. Makes much more sense to have this work in OPW. Including public pathways.

e. Advocacy issues-Elizabeth Stage

## **DECISION:**

Given obstacles and current OFSC resources, it does not make sense to continue investing efforts into State legislative affairs. Local advocacy – including regional efforts – continue to make sense. This is where OFSC has demonstrated added value and traction.

The group agreed that moving 200 or so regular donors to sustaining donors is a priority. They are exploring working with Network for Good, a donation search engine that would manage the monthly donations, and have money flow seamlessly to OFSC bank account.

The group also discussed whether we need a written policy to govern corporate philanthropy.
